With reference to the certain recommendations /suggestions made by Chairman, G.N.M.I.A.S, Autonagar Visakapatnam on Revised Guidelines in the functioning of IALAs & Service Societies, it is to inform that after review and examination, the following clarifications are given. Please take necessary action accordingly.

As per APIIC –IALA revised guidelines, under the heading IX.(Elections of Service Society

	Guidelines issued	Suggestion/Recommendations of the Society	Clarification.
f.	Under no circumstances, proxy voting shall be allowed except through postal ballot by the authorized voters as aforesaid.	The concept of postal ballot is mainly to facilitate the employees on election duty. There is no necessity of postal ballot in the lection of GNMIAS. Hence under any circumstances Proxy voting or postal ballot shall not be allowed	No amendment is required.
g	The tax payers those who are not defaulters in payment of property tax are eligible to contest for the post of managing Committee including office bearers in the elections to the Managing committee of Society.	The tax payers those who are not defaulters in payment of property tax of all the units existing on his/her name as proprietor or having any share holding in a partnership firm or Pvt Ltd company or Limited company are eligible to contest	The tax payers those who are not defaulters in payment of property tax of all the units existing on his/her name as proprietor or having any sharehold in a partnership firm or Pvt Ltd., company or Limited company are eligible to contest for the post of Managing Committee including office bearers in the

			elections to the Managing Committee of Service Society
k	No Managinig Committee office bearer or member is allowed to contest again if he has tax arrears of more than half year at any point of time.	This clause restricts the members to participate in elections if they had any arrears at any point of time due to number of reasons.  We recommend for the following suggestions.  No Managing Committee bearer is allowed to contest if he has tax arrears at the time of filing nominations.	The contesting unit/member must not be a defaulter of any taxes,fees at the time &date of scrutiny of the nominations for contesting to to the post of the Managing Committee.

Therefore, the above amendments to the IALA guidelines are come into force with immediate effect.
