ORDER:

In the reference 1<sup>st</sup> read above, the State Investment Promotion Board (SIPB) in its meeting held on 12.05.2022 decided that "all the land allotments made by APIIC below 50.0 Acres, shall be placed before the Cabinet for ratification, while all other allotments of 50.0 Acres and above, shall be placed before the Cabinet for approval as per the existing procedure".

2. Based on the proposals submitted by the VC&MD., APIIC Ltd., and also keeping view of the decisions of the SIPB in the reference 1<sup>st</sup> read above, Government vide G.Os. 2<sup>nd</sup> to 6<sup>th</sup> read above have ratified the action of the APIIC Ltd., towards allotment of lands below 50.00 Acres as approved in the SLAC and DIEPCs in their meetings.

In his Letter 7<sup>th</sup> read above, the VC&MD., APIIC Ltd., has furnished the total 110 applications which were approved in State Land Allotment Committee (SLAC) and the District Industrial and Export Promotion Committee (DIEPC) meetings held during the period from 10.11.2023 to 06.12.2023 and requested the Government for ratification of the action taken by APIIC Ltd., for allotment of lands below 50.00 Acres as per the decision of SIPB in its meeting held on 12.05.2022.
