Andhra Pradesh Industrial Corridor Development Authority, Directorate of Town and Country Planning, Municipal Administration and Urban Development Dept. have been identified as one of the nodal agencies for fulfillment of approval related requirements and fast-tracking the approval processed for the Industrial Parks. Government of Andhra Pradesh has launched a Single Desk Portal (SDP) as a one-stop-shop for helping the investors to obtain all the regulatory clearances required to set-up and operate businesses. The SDP supports end-to-end transaction processing with online payment and application status tracking. Investors can obtain clearances from all the concerned departments with respect to all the requisite pre-construction and pre-operation approvals. Further, APIIC shall provide reasonable support and assistance to the Selected Developer in procuring all the Applicable Permits required from any Government Instrumentality for implementation and operation of the Project.
